If no valid and functional email address is provided by you, whether in the Request Form or if you are otherwise deemed to have consented to receive future Corporate Communications in electronic form through the Company's website, the Company will send to you by post at your address as it appears in the Company's register of members maintained by the Company's Registrars, (i) a notification letter for the publication of Corporate Communications on the Company's website and (ii) all future Actionable Corporate Communications in printed form, until such time when you have provided a valid and functional email address to the Company's Registrars for receiving the same.

If you have elected (or are deemed to have elected) to receive Corporate Communications in electronic form through the Company's website but for any reason have difficulty in accessing the Corporate Communications electronically, the Company will upon your request send the printed copies to you free of charge.
