

Cathay Rewards Annual Travel Cover Discount Offer for Vantage Pass Customers Terms and Conditions

1. This Cathay Rewards Annual Travel Cover Discount Offer for Vantage Pass Customers (this “**Offer**”, as described in greater detail below) is organized by Cathay Pacific Airways Limited (“**Cathay**”), Asia Miles Limited (“**AML**”, and herein referred to together with Cathay as “**Cathay/AML**”, “**us**”, “**we**” or “**our**”) and Chubb Insurance Hong Kong Limited (“**Chubb**”).
2. This Offer commences on 20 December 2024, 00:00 and ends on 28 February 2025, 23:59 (both days inclusive, Hong Kong Time, GMT+8) (the “**Promotion Period**”).
3. Members of Cathay Membership Programme who successfully purchase a Vantage Pass on [Cathay’s designated website](#) or from a designated travel agent during the Vantage Pass Promotion Period are eligible to participate in this Offer (herein referred to as “**Eligible Participants**”, “**you**” or “**your**”).
4. You acknowledge and agree that by participating in this Offer, you are agreeing to these terms and conditions and any amendments or variations to these terms and conditions.
5. The following capitalised terms used in these terms and conditions have the meaning ascribed to it:

“**Cathay Membership Programme**” means the loyalty and rewards programme operated by AML (as such programme may be renamed, rebranded, amended or replaced from time to time);



“**Eligible Plan**” means the Cathay Rewards Annual Travel Cover for their journey departing from Hong Kong;

6. After purchasing a Vantage Pass, Cathay will send an email (“**Promotion Email**”) containing a one-time Voucher code to the Eligible Participant at their registered Cathay Membership Programme account email address after 20 December 2024.

(ii) In **Step 2 – Personal Details** page provide a valid Cathay Membership Programme membership number and Vantage Pass booking reference. Then, in **Step 3 – Declaration and Payment** page, enter the Voucher Code to receive a premium discount.
